PROCESSING PROCEDURES OF APPLICATION

އިދާރާތަކުން ފަތުރުކުރުމަށް ފުރުޞަތު ލިބޭނެ ގޮތް

- If all information and document has been provided as requested above, the application will be processed within 6 working days.
Requested initial payment and installment period may change during the approval process.
If the requirements of the application are fulfilled, BMC will contact the applicant to make arrangements for the advance payment.
Initial payment must be paid within 15 working days of being informed. If the applicant fails to pay within the said period, application form will be canceled.
In the event that an applicant requests to change the motorcycle model or a refund after making the advance payment, a deduction of MVR 1,500.00 will be applied to the amount paid.
The requested model cannot be changed after advance payment.
Upon receipt of initial payment, BMC will make all necessary arrangement for Hire-purchase agreement and handing over of the motor cycle.
After the agreement signing has been scheduled following advance payment, if the applicant fails to be present for agreement signing within the next 15 days, application form will be cancelled, and the advance payment will not be refunded.

SUMMARY OF THE MAIN PROVISIONS OF THE AGREEMENT

- 1. The agreement shall be binding on both parties upon signature.
2. The down payment shall be completed on or prior to the date of signing the agreement.
3. The motorcycle will be handed over to the Purchaser only after signing the agreement and completion of the registration of the motorcycle.
4. The motorcycle will be registered in the name of the Purchaser.
5. The motorcycle will be handed over with a warranty. The dealer of the motorcycle will be responsible for providing the services under the warranty.
6. The motorcycle shall be used in the Zone stated in the agreement. The Zone can be changed only after informing the Seller as per the Agreement.
7. Monthly payments shall be made regularly in accordance with the payment schedule stated in the agreement.
8. Where payments are not made by the due date, 0.5% (zero point five per cent) shall be charged on all outstanding unpaid amounts for each additional day from the payment due date as compensation for losses incurred by the Seller due to the delay.
9. Payments shall be accepted and deducted for bills as per the procedure set out by the Seller.
10. Where this Agreement is terminated for any reason, the instalment payments made up to that point under the Agreement shall be deemed as lease payments for the motorcycle.
11. Where the Seller pays any penalties or any other fees related to the motorcycle, the Purchaser shall pay the Seller an administrative fee amounting to 31.8% of the penalty or fee amount within 5 (five) days of making any such payments.
12. The Purchaser shall be responsible for any damages to the motorcycle during the term of the Agreement and any losses incurred due to theft or losing the motorcycle or any other reason whatsoever.
13. The Purchaser shall reimburse the Seller for all costs incurred due to the Purchaser breaching any provision of this Agreement, where such costs shall include but not be limited to, legal fees, repossession costs, storage costs, and repair costs.
14. The Purchaser shall not sell, gift, lease, or do any other act that would create rights of a third party over the Motorcycle prior completion of all payments and other obligations under the Agreement.
15. In the event where any information of the Guarantor or Purchaser has been revised, the Purchaser shall be responsible for the timely handover of any such amended or revised documents.
16. The Seller or any person appointed by the Seller shall have the right to inspect the motorcycle by giving 24 (twenty-four) hours advance notice.
17. The Purchaser shall be liable for all costs incurred and outstanding payments in relation to the Motorcycle during the period of the Agreement.
18. The Guarantor who has provided their personal guarantee shall be liable to the same extent as the Purchaser for all of the Purchaser's obligations.
